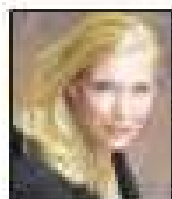

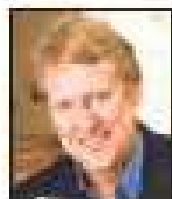
Instreet hires Bransgrove
